Ways to give

RESIDUAL GIFT*

PERCENTAGE GIFT*

A nominated percentage of your Estate.

**Both residual and percentage gifts maintain their value over time, and are less influenced by economic changes.*

PECUNIARY GIFT

Is the set dollar amount chosen by you when drafting your Will. It is best to review your Will frequently, so your intentions are not eroded by inflation over time.

SPECIFIC GIFT

An item such as property, shares, jewellery, art work or insurance policies can be donated.
