Pioneering health delivery for people experiencing homelessness

Thanks to generous seed funding provided by the Lord Mayor's Charitable Foundation,

St Vincent's Hospital Melbourne (SVHM) is laying the foundation for offering safe accommodation to people experiencing homelessness for the duration of their medical treatment.

St Vincent's Emergency Department receives approximately 4,000 visits from people experiencing homelessness every year.

Whilst we work hard to secure a supported discharge for people

following their stay, our options are limited. It is estimated around 50% of these patients are discharged back onto the street, something we are committed to changing.

The Lord Mayor's Charitable Foundation (LMCF) provided seed funding for a feasibility study to be undertaken to assess the conversion of a hospital-owned property, Salisbury Place, into a 'fit for purpose' accommodation facility.

We are extremely grateful to the Lord Mayor's Charitable Foundation for their visionary support of this project that will innovate how we deliver healthcare to patients experiencing homelessness.

A partnership of 69 years

The Collier Charitable Fund and St Vincent's Hospital are looking back on a 69-year partnership, driven by closely aligned values and a shared desire to provide excellent health care to all.

"One of the areas of focus for the Collier sisters was strengthening Victorian public hospitals. This focus is reflected in the work that St Vincent's Hospital undertakes which is just as important today as it was when the Fund commenced in 1954," Wendy Lewis OAM, Executive Officer, Collier Charitable Fund.

The Collier Charitable Fund's most recent, generous grant of \$50,000 has enabled the creation of a patient information database for the Hospital's Breast Surgery Unit. The new portal, called BRENDA, will collate patient medical information, to include a routine collection of patient-reported outcomes. Its holistic approach promises to improve breast surgery patient treatment and outcomes for generations to come.

Breast surgeon, Jocelyn Lippey, said the creation of BRENDA has been a dream shared with Head of Breast Surgery, Caroline Baker, for the past five years. "We feel so fortunate to receive this funding that will enable our dream to become a reality."

Revolutionising the way we repair skin

Damage and loss of skin is a major challenge and a burden on healthcare with approximately 5,500 people hospitalised in Australia each year. These injuries often result in numerous re-admissions and long lengths of stay.

In partnership with the F&E Bauer Foundation, a team of Aikenhead Centre for Medical Discovery (ACMD) researchers is investigating the development of a process capable of producing a 3D printed material with similar properties to human skin. The aim is to use this for the treatment of cancer, trauma and burn victims and to aid recovery after major operations. Cecilia Gason, Manager of The F & E Bauer Foundation at Equity Trustees said, "Dr Frederick Bauer established the Foundation with the aim of promoting research in Dermatology. This cutting-edge research by St Vincent's has the potential to change the lives of those with serious cancers, burns and other dermatological issues. It is precisely the type of project that Dr Bauer would have dreamed of supporting when creating the Foundation."

The F&E Bauer Foundation has generously supported the project since its inception 12 years ago.

Engineering the future of healthcare

Our Fitzroy Campus is a unique microcosm of our health system. Here, we can make healthcare inclusive, excellent and innovative.

St Vincent's Health Australia is committed to research excellence and has a strong track record of success in research and its translation. Equally, as a teaching hospital, St Vincent's remains focused on nurturing the future leaders of medicine by providing an optimal learning experience that combines on-the-job training, supervision and mentoring.

In recognition of the crucial role research and education will play in the transformation of healthcare, St Vincent's Hospital Melbourne has partnered with eight leading institutions across research and education to jointly engineer the future of healthcare through the Aikenhead Centre for Medical Discovery (ACMD).

The ACMD will focus on biomedical engineering research and teaching, drawing on insights from human biology, engineering principles and design paradigms to transform how we identify, prevent and treat trauma





and disease. Our patients provide the focus for the work of the ACMD and anchor the Centre's work in clinical need.

To enable deep collaboration and knowledge exchange across our organisations and areas of expertise, we are building a new physical home for biomedical engineering research and teaching on St Vincent's Hospital Melbourne's Fitzroy Campus. Set to be completed by the end of 2024, the 11-storey ACMD building will celebrate the high-performing collaboration culture that underpins our partnership.

With the knowledge that people are at the heart of all meaningful change, teaching will be central to the ACMD to nurture Australia's future clinical, nursing, allied health, and biomedical research leaders.

It will provide graduates with the knowledge and skills to understand and solve major health problems and position Australia at the forefront of biomedical engineering innovation. We are certain that by pooling our expertise and resources, our partnership will increase the rate of biomedical engineering discoveries, whilst accelerating their translation into tangible solutions.

We now seek likeminded partners in the community to help us lift our ambition further and realise the ACMD's full potential.
